

WAIVER AND RELEASE AGREEMENT



Please read carefully before signing! This is a release of liability and waiver of certain legal rights. In consideration for my being permitted to participate in the activities of Shotgun Shooting, I agree to the following Waiver and Release:

I acknowledge that clay target shooting has inherent risks, hazards, and dangers for anyone, that cannot be eliminated. I UNDERSTAND THESE RISKS, HAZARDS, AND DANGERS AND ACKNOWLEDGE THAT THEY INCLUDE WITHOUT LIMITATION:

- 1. The risk of handling firearms and being near others that have firearms in their possession.
- 2. The risk of ear damage from noise and the risk of eye(s) injury. For eye and ear protection, we recommend use of ear plugs and protective eye glasses. If you do not, you are doing so at your own RISK.
- 3. The risk of injury from ammunition, clay targets and shots from other guns
- 4. Inclement weather condition. I understand the risks, hazards, and dangers as described.

I understand these activities may require a degree of skill and knowledge. I believe I have the needed skill and knowledge necessary to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS OR DEATH. I, for myself, my heirs, successors, executors and subrogees, hereby KNOWINGLY AND INTENTIONALLY, WAIVE, RELEASE, INDEMNIFY AND HOLD HARMLESS from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis or death to me or my property as a result of my engaging in these activities or the use of these services and/or equipment, whether such damage, loss, injury, paralysis, or death results for negligence of Iron Mountain Sports LLC, their directors, officers, agents, employees, volunteers, Kirk Eastin, Jim Deanda and/or Chad Dixon and/or Mission of Hope, Inc. their directors, employees and/or volunteers, or from some other cause.
